ANNUAL LICENSE RENEWALS

All annual license renewals will be mailed out in the month of May. License renewals are due by June 30, 2019. As a reminder, any resident that operates a business from their home is required to obtain a Home Business License and pay an annual fee of \$25.00. Please contact the Building Department at (815) 741-5106 to make sure your home business meets the requirements to operate in a Residential District. Also, any resident or business that has a burglar alarm protection device must obtain a license from the Clerk's Office. A Burglar Alarm License is needed if it automatically transmits a signal, message or warning to the Police Department telephone or a signal which once verified by a central receiving unit results in a call to the Police Department. The fee for the Burglar Alarm License is \$50.00 for the first year and a \$20.00 renewal fee every year after. FILE OF LIFE EMERGENCY CARDS

Medical emergencies can happen anytime. When they do, there is confusion, panic and urgency. Paramedics arrive on the scene with no information about the person in need. The File of Life Emergency Card provides information such as medical conditions, allergies, medications and who should be contacted in the event of an emergency. The card is completed with all this information and placed in a magnetic pouch that can be displayed on your refrigerator. The File of Life Emergency Card is recognized by first responders which allows them to

immediately begin the best possible treatment. The File of Life Emergency Cards are available at City Hall at no cost to residents. For further information or questions please contact the Clerk's Office at (815) 741-5100.

MEDICINE DROP OFF BOX

Residents are invited to drop off their unwanted prescription medications in the Green Drop Box located in the foyer of City Hall. Medications can be dropped off Monday through Friday between the hours of 8:00 a.m. and 4:30 p.m. Please black out any personal information on the containers before dropping them in the bin. Acceptable items are prescription medications – both liquid and solids, over the counter medications and pet medications. Non-Acceptable items are sharpies (needles), aerosol canisters and inhalers.

ELECTRONIC RECYCLING

Will County offers a free electronic drop-off program. All electronic items are accepted at the drop-off locations. Please note a limit of 2 televisions per vehicle are allowed per visit and please remove all batteries from items before drop off. SPRINGING INTO DEVELOPMENT

The spring and summer months will be full of activity throughout the City of Crest Hill. New developments will start taking shape while others are forming behind the scenes – all to make the Crest Hill community a better place to live, work, and shop.

Weber Road around the library will once again come alive with the addition of a new Speedway gas station. This

facility will be located at the corner of Weber Road and Patrick Drive, just north of the library. Expected to break ground this spring, Speedway will offer a café, convenience center, and gaming as well as several bays for filling your tank. The developers at Speedway are hopeful to have construction concluded and be open for business by Labor Day.

A few minutes down the road at 1804 Larkin Avenue will stand another new development. Fuller's Car Wash, who purchased the location in 2018, is getting set to erect a brand new state of the art car wash. Fuller's Car Wash, whose brand is well recognized throughout the Chicago-land area, will offer \$3 Express Wash with free vacuum bays. This car wash is sure to bring more attention to Crest Hill and should be open for business before the end of 2019.

AMAZON CONTINUES TO GROW

The Amazon Sort Facility located on Division Street and Churnovic Lane has decided to expand its operation indoors. A \$22 million conveyor extension will be added onto an already sophisticated and efficient operating system inside the nearly four hundred fifty square foot building. This addition will allow for smaller packages to be sorted and sent out to reach their destinations much faster.

In Illinois, Amazon has invested over \$3 billion and created over 12,000 full-time jobs (with competitive pay and benefits). The online mega-giant also has indirectly created over 13,000 jobs and help support 73,500 small and medium sized businesses, developers and authors by growing their business with Amazon. Since 2015, Amazon has launched five fulfillment centers across Will County in Joliet, Romeoville, Monee, and right here in Crest Hill.

MOVE OVER LAW

Illinois has experienced the tragic loss of several brave Law Enforcement Officers in recent months. Trooper Christopher Lambert January 12, 2109. Trooper Brooke Jones-Story March 28, 2109, Trooper Gerald Ellis-March 30, 2019 are recent examples. These deaths involved a lack of awareness, and could definitely be avoided.

Law Enforcement Agencies have stepped up efforts to crack down on drivers who do not follow Scott's Law, formally known as the, "Move Over" Law.

The law is very simple, when you are approaching a stationary emergency vehicle or any vehicle with flashing lights, that is on the roadway or shoulder of the road you are to:

- Slow down
- Change lanes , if possible
- Proceed with caution

Please do your part to keep our roadways safe and remind friends and family to remember "Scott's Law".

MEMORIAL DAY WEEKEND

Known as The 100 Deadliest Days for drivers, the stretch between Memorial Day and Labor Day can be extremely dangerous for drivers of all ages. Memorial Day weekend is typically considered the start of summer, where people all over the United States will be celebrating with cookouts, barbecues, parties and plenty of alcohol.

When most people think of hitting the road to travel over a long weekend, they think of the dreaded traffic. Travelers can certainly expect to see a spike in traffic, with some trips expected to take 50 to 100 percent longer than average. While the frustration of traffic can be very real, not all Memorial Day statistics are so innocent.

Data from the National Highway Traffic Safety Administration (NHTSA) shows that an average of 400 people are killed in traffic accidents and similar incidents during Memorial Day weekend. Drink responsibly--it's not just a slogan.

As families and friends gather together to enjoy Memorial Day, the food and booze can often flow freely. According to the NHTSA, 44 percent of traffic fatalities over Memorial Day weekend involve alcohol.

You can still have plenty of fun over Memorial Day weekend--you just want to make sure you are doing so responsibly.

Here are some simple steps you should remind yourself and your friends to follow:

- Plan ahead. Make sure you have a ride home or have a place to crash ahead of time.
- Limit the alcohol. If you're a host, play it smart. Keep your guests safe and limit the amount of drinks you provide.
- Keep the food coming. Whether you're a party host or guest, make sure you have plenty of food and snacks throughout the festivities.
- Report drunk drivers. If you're on the road, leaving a restaurant or bar, or any other place and notice a drunk driver, report it!

The statistics don't lie. Memorial Day weekend can be extremely dangerous for travelers hitting the road. Do your

part to keep the roads safe and make sure your holiday weekend is memorable for all the right reasons.

This Memorial Day, commit to only driving 100 percent sober, because buzzed driving is drunk driving.

EMERGENCY NOTIFICATION SYSTEM

By enrolling in the Smart Message - Community Alert Network, you can now stay connected by receiving up to the minute Emergency Alerts from the City of Crest Hill regarding immediate or pending threats to public safety or property, where immediate notification is necessary.

Examples include evacuation recommendations, boil orders, water main breaks, and crime alerts.

As a Resident of Crest Hill, you can also elect to receive Announcements, Notices, and Public Safety Non-Emergency information sent to your home phone, work phone, texted to your cell phone, or emailed to you between the hours of 6 am and 9 pm. You can select how you receive the information based on the contact information you provide during the sign up process. Examples include:

- Announcements - May inform you of scheduled water and sewer repairs. Messages may also inform you of scheduled street closures, resurfacing projects, and parking bans.
- Notices - May consist of community information regarding upcoming festivals, changes in garbage pick-up, and community press releases.
- Public Safety Non-Emergency Information - May include messages from local officials with information about crime prevention information, public safety events, neighborhood crime alert information, and fire hydrant testing.

NOTE: This notification system will not notify you of severe weather that may be near, for that information several other applications are best for you, including television, weather radios and many phone applications.

MEMORIAL DAY CEREMONY

LIDICE MEMORIAL CEREMONY

Please join us as we celebrate our 77th annual Lidice Memorial Ceremony, Sunday, June 9, at 11:00 AM at the Prairie Avenue/Hosmer Lane Memorial Garden. This solemn ceremony honors those who perished in 1942 during World War II when the Village of Lidice, Czechoslovakia was destroyed. The City of Crest Hill and Phillips, Wisconsin are the only two communities in the United States that commemorate this tragedy. The ceremony should last approximately 1 hour and refreshments will be served following the program.

POTHoles POP UP EVERYWHERE

Spring weather brings us much desired relief from a long cold winter. Spring also means it's time for pothole repairs to get into full swing. Members of Crest Hill Public Works fill potholes at various times throughout the year. However with spring rains and warmer weather, pot holes become a major concern for the City's roadways.

Potholes form when water enters cracks in the road surface, expanding and damaging the surface as it freezes. Cars further damage the roadway forming a pothole that only increases in size without attention.

During winter months, Public Works crews make routine repairs throughout the city using a cold mix asphalt to fill in potholes. The cold mix asphalt is ideal for making pothole repairs because it retains its corrective properties during long periods of storage. Also, it is not necessary to heat this material prior to use. Crews begin using hot mix

asphalt during warmer months when asphalt plants are in operation and the material is available.

If you spot a pothole that needs attention, please contact Public Works at 815-741-5108. Crewmembers are usually able to make repairs within two business days.

IMPROPER STORMWATER HOOKUPS

During the rainy season, many sanitary sewers throughout the city become overloaded by rainwater resulting from the improper connection of sump pumps, and gutters and/or downspouts. Please remember that City Ordinance 15.21 makes it illegal to direct any storm or rainwater to flow directly into the sanitary sewer system. Property owners should pump this clear water either onto the ground or in the stormwater collection system.

If you would like to remove an illegal connection into the sanitary sewer system, the City offers a 50/50 cost-sharing program where residents may receive a reimbursement of up to 50% of the cost (\$4,000 maximum).

Interested residents should contact the Building Department for more information on the program. The Utilities Department is available to help property owners determine if their building contains an improper connections and how to identify it.
