

ORDINANCE NO. 1894

**AN ORDINANCE DISCONTINUING THE OFFICE OF HUMAN RESOURCE
MANAGER AND REPEALING CHAPTER 2.30 OF THE CREST HILL CITY CODE**

WHEREAS, the City Council of the City of Crest Hill has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the City Council previously created an office of Human Resources Manager for the City of Crest Hill and codified said office in Chapter 2.30 of the Crest Hill City Code; and

WHEREAS, the City Council has determined that the office of Human Resources Manager is no longer necessary, expedient, and advantageous for the best interests of the City and its citizens; and

WHEREAS, pursuant to Section 3.1-30-5(b) of the Illinois Municipal Code (65 ILCS 5/3.1-30-5(b)), the City Council is authorized, by a two-thirds (2/3) vote, to discontinue the office of Human Resources Manager and devolve the duties of that office on any other municipal officer; and

WHEREAS, the City Council has determined that it is necessary, expedient, and in the best interests of the City and its citizens to discontinue the office of Human Resources Manager, devolve the duties of said office upon the City Administrator, and repeal Chapter 2.30 of the Crest Hill City Code, all as set forth in this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CREST HILL, WILL COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1: The City Council hereby finds that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2: Title 2 (Administration and Personnel), Chapter 2.30 (Human Resources Manager) of the Crest Hill city code is hereby repealed and reserved.

SECTION 3: The office of Human Resources Manager for the City of Crest Hill is hereby discontinued. All present duties and responsibilities of said office are hereby and shall be devolved upon the office of City Administrator.

SECTION 4: In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.


SECTION 5: That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 6: That the City Clerk is hereby directed to publish this Ordinance in pamphlet form.


SECTION 7: That this Ordinance shall be in full force and effect from and after the end of the current fiscal year as provided by law.
